

Membership Agreement August 1, 2024 to July 31, 2025

Spotsy United is a program of the Fredericksburg Soccer Club Incorporated. This agreement is made between the Fredericksburg Soccer Club Incorporated (hereafter "FSCI") and the parent or legal guardian listed below for the benefit of the child listed below. This agreement supersedes any previous agreements. There are no other oral or written promises, conditions, or understandings relating to the subject matter of this agreement.

<u>MEMBERSHIP</u>: I understand that the child can be a member of any individual season contingent upon payment. The membership term begins with the event that occurs last; the first payment for a season or the first event of a season. The term ends with the last event of a paid season. The member is the child.

CONDUCT: If a parent, legal guardian, or child violates the Code of Conduct, FSCI reserves the right to terminate the child's membership. I agree with the consequences in the Code of Conduct.

PAYMENT: There are no refunds regardless of reason or circumstance. I agree to the no refund policy and not to request a refund. I agree that I am responsible for payment of my child's membership dues.

SEVERABILITY: If any provision of this agreement is determined to be invalid, illegal, or unenforceable, it shall not affect the enforceability of any other provision of this agreement. Rather, the invalid, illegal, or unenforceable provision shall be modified to the extent necessary so that it is valid, legal, and enforceable.

<u>FORCE MAJEURE</u>: FSCI shall not be considered in default of its obligations to the member if there exist events beyond its reasonable control including without limitation, acts of God, acts or omissions of governmental authorities, acts of public enemy, wars, acts or threatened acts of terrorism, blockages, riot, civil disturbance, epidemic, pandemic, flood, hurricane, tornado, inclement weather, field closure, opponent withdrawing from a game, and any other similar events, acts, or omissions beyond the control of FSCI.

IMAGE & VIDEO CONSENT: I hereby grant permission to FSCI to photograph images, video record, or audio record my child at events. The images, video, or audio will be used as an educational tool for learning, highlighting events, or to recognize a player for an accomplishment. The images, video, or audio may appear in various media beyond this membership term. FSCI will not publish the child's full name in any media unless a separate release form has been signed. I waive any rights to royalties or other compensation arising or related to the use of the images or recordings.

<u>PARTICIPATION CONSENT</u>: I do hereby consent to my child's participation in all activities. I do hereby release and agree to hold harmless FSCI, and all persons engaged in the program for all injuries received by virtue of my child's participation in the program. Insurance for injuries that may be received while participating in the program is the responsibility of the parent or guardian. FSCI shall not be held responsible for injuries of a child or for the failure to medically insure the child participating in the program. I am aware that participation includes a risk of injury such as a broken bone, concussion, etc. I accept the risks of participation.
